**DUTIES INCLUDE:** The paralegal shall assist the External Relations Department in providing important updates regarding NSLS, our mission, or legal advocacy tips to Long Island residents and advocates. Such assistance includes but is not limited to drafting and posting NSLS updates and advocacy tips via social media (such as Twitter, Facebook, Instagram, Linked-In, etc.), emailing through Constant Contact, drafting print newsletters; assisting with presentations for Long Island advocates by creating PowerPoint presentations or recordings; and/or assisting with updating website content and intranet content via Microsoft SharePoint. Additionally, tasks include data-entry and working to organize and recruit volunteers and new employees.
